Corporate Membership is subject to approval of BAPCO's Board and Executive Committee.

Your organisation **must** nominate an **Account Administrator** to be the main contact between your organisation and BAPCO for invoicing and for all information on discounts included in the package. Any changes to this main contact person must be notified to BAPCO as soon as practicable.

Individual members will receive regular membership emails and members' benefits such as website access and the quarterly Journal in the usual manner.

Individual membership is offered at the discretion of the Account Administrator representing the Corporate Membership and is open to new and existing BAPCO members. For existing members their membership will be changed over immediately to reflect the Corporate package purchased. No refund of any individual membership subscription already paid will be given.

Corporate Membership will run on a rolling subscription basis and will be automatically renewed each year unless cancelled in writing in advance of the renewal date by the organisation's Account Administrator.
